1	20140928001	Soldier was apparently operating his POV at a high rate of speed when he exited the roadway and struck a tree. The vehicle burst into flames and the Soldier and the passenger were severely burned. Both was pronounced deceased at the scene.
2	20140921001	Soldier was traveling in her POV with her 10-year old son when her vehicle was struck by a fast approaching vehicle at an intersection. Soldier was pronounced dead at the scene and her son and the other driver were medevaced for injuries.
3	20140914001	Soldier was proceeding on the roadway when his vehicle reportedly crossed the center (turn) lane and collided head on with an SUV in the opposing lane of traffic. Soldier was pronounced dead on the scene. The passenger of the SUV also passed from his injuries. Seatbelts not reported.
4	20140903001	Soldier driving a late model 3-series BMW, was negotiating a curve and entered the left oncoming lane. The Soldier's car, collided with the truck head on, destroying the car and killing the Soldier instantly. Soldier was wearing his seatbelt.
5	20140827001	Soldier1 was operating his Honda Accord when he was rear-ended by a Jeep Liberty, being driven by Soldier2. The collision resulted in a 4-vehicle sequential impact. All 4 drivers were injured but Soldier1 succumbed to head trauma injuries on 29 Aug, following removal from life-support.
6	20140821001	Soldier lost control of vehicle and hit a power line guide wire. The car flipped and hit a nearby tree. Emergency services responded shortly thereafter and Soldier was pronounced dead at 2151.
7	20140816001	Soldier crashed and was fatally injured while operating his POV.
8	20140811001	Soldier was driving his POV en route to his HOR when a tractor trailer traveling in the opposite lane crossed the median and overturned and collided with the Soldier's POV. His vehicle burst into flames igniting the truck. The Soldier was pronounced at the scene.
9	20140810001	Soldier was fatally injured in a vehicular accident while en route to his HOR from his battle assembly/duty location. His brother traveling with him, whom also is a Reservist is listed in critical condition. Alcohol/Seatbelt is unknown at this time.
10	20140807003	Soldier was traveling on State Route when his vehicle struck head on by another vehicle that entered his lane of travel. He was pronounced deceased by County Coroner.
11	20140802003	Soldier was presumably en route to his IDT location when he was involved in a vehicular accident as fatally injured. Soldier failed to report for duty after notifying his supervisor that he would be late.
12	20140802002	Soldiers were returning to their barracks from a nightclub when the driver lost control of the vehicle. The vehicle rolled several times and the left-rear seat passenger was partially ejected from the vehicle and suffered fatal injuries as a result.
13	20140712001	Soldier crashed after losing control of her vehicle. Soldier was wearing a seatbelt. Soldier was in IDT status at the time of the accident.
14	20140625001	Soldier struck a tree while driving on the interstate highway and was pronounced dead at the

		scene.
15	20140620001	Soldier was operating his POV on his way back from annual training when he rear ended a semi-trailer on the highway. The vehicle caught fire and the Soldier died from his injuries.
16	20140610001	Soldier was operating his POV truck when it rolled numerous of times and ejected him from the vehicle.
17	20140601002	Soldier apparently lost control and crashed his vehicle while traveling through the JBLM housing area. Soldier was pronounced dead at the scene.
18	20140511001	4 Soldiers were traveling in a PMV-4 when the driver/owner apparently lost control and struck a concrete barrier. Vehicle overturned and the one Soldier-passenger (SPC) was pronounced dead at the scene due to injuries
19	20140510002	Soldiers were occupants of a dual-cab pick-up truck when it overturned in an off-road public area. Front seat Soldier passenger sustained fatal injuries and was pronounced dead at the scene. Driver sustained minor injuries.
20	20140423003	Soldier was driving when he apparently lost control of his vehicle, left the road, and entered an adjacent wooded area. Soldier is suspected of not having worn his seatbelt although not ejected and was pronounced dead at the scene.
21	20140419001	Soldier was involved in a vehicular collision while at his HOR on PCS leave. He ultimately passed from his injuries on 24 APR 14, 0100
22	20140411008	Soldier was operating his POV attempting a left-hand turn on the divided Hwy when he was struck on the passenger side by an oncoming SUV. Another vehicle then struck the SUV, resulting in a 3-vehicle collision. Soldier was medevaced for treatment and succumbed to his injuries on 13 Apr.
23	20140406001	1SG was operating his POV with another COARNG Soldier as a passenger (SPC), en route to their IDT location when they crashed for UNK reasons. SPC was trapped inside the vehicle and pronounced dead at the scene. 1SG is admitted as an in-patient with serious injuries.
24	20140321020	Soldier was en route to his AT location when he lost control of his vehicle, struck an embankment, and overturned multiple times, during which he was reportedly ejected. Soldier was carrying 3 (nonmilitary) passengers who sustained survivable injuries.
25	20140320002	Soldier was towing another vehicle on the interstate with his pick-up truck when he was struck from the rear by a flat bed lumber truck. Soldier was pronounced dead at the scene and later identified. Soldier was in leave status at the time of the crash.
26	20140320003	Soldier was traveling en route to his drill location when he apparently lost control of his POV on a dirt road and struck a tree at an intersection resulting in a fatal injury.
27	20140309002	Soldier was fatally injured in a single vehicle accident while en route to drill. He passed from his injury after evacuation to a local hospital
28	20140309001	Soldier was riding as the right-seat passenger in a pick-up driven by a civilian private party when it went off the road and struck trees. Soldier was ejected and was pronounced dead at the scene.
29	20140301001	Soldier was driving a POV to IDT. His POV went off the road. He overcorrected and lost control. As a result to POV struck numerous obstacles and overturned ejecting him from the POV. He was pronounced DOA at local medical center. He was not wearing a seat belt,
30	20140227001	Soldier was traveling on the highway in his Ford Escort in rainy conditions when an oncoming vehicle crossed the center line after hydroplaning from the opposing lane and struck the Soldier's vehicle head on. Soldier was wearing his seatbelt but sustained fatal injuries.
31	20140121001	Soldier was operating his POV, following release from duty, when he left the road and struck a guard rail. Soldier was pronounced dead at the scene following the crash.
32	20140116001	Soldier was operating his POV and lost control while exiting the freeway via an off-ramp.

		Soldier's vehicle overturned and came to rest inverted. Soldier and his passenger were medevaced and he expired from his injuries on 19 Jan 14, 1102 local. Passenger is listed in serious condition.
33	20140112001	Soldier was involved in a single occupant/single vehicle accident that resulted in fatal injuries.
34	20131221001	Soldier apparently struck a tree while operating his POV. The accident scene was discovered at 0331, on 21 Dec 13 and he was pronounced deceased at the scene.
35	20131214002	Soldier was operating his POV with his wife as a passenger when they struck a guard rail. Their vehicle overturned 3-4 rotations, ejecting both occupants who sustained fatal injuries. S/B use TBD.
36	20131128001	Soldier was operating his POV when he struck a telephone pole, reportedly en route to a local store. Soldier was reportedly wearing his seat belt and was trapped inside the vehicle when it caught fire. Soldier suffered burns to 80-90% of his body and succumbed to his injuries later that night.
37	20131117001	Soldier's POV was witnessed to have been going at a high rate of speed when it crashed. His identity remains to be verified in the wake of a post-crash fire but is assumed, based on registration of his vehicle and Army-issue outer wear.
38	20131112002	Soldier struck the rear end of a tractor trailer that was stationary on the side of the highway. Soldier was pronounced dead at the scene.
39	20131106001	SGT was operating his Dodge sedan, proceeding through a light controlled intersection, when he collided broad-side with another Soldier's vehicle. Soldier was pronounced dead at the scene. 2 <sup>nd</sup> vehicle (Mazda) operator (PV2) sustained arm-fracture and is currently hospitalized.
